**EXHIBITING RULES**

- Exhibitor names need to be submitted by May 5, 2009
- Booth decorations need to be fire retardant, no boxes can be in the booth (just under the table)
- No lightweight extension cords
- Traditional upright display units up to 6' wide and 8' tall will fit within all exhibit spaces
- Exhibitor is responsible for own signage; banner may be hung on front of table (bring own table clips)
- Hooks will be available to hang banners from pipe & drape. You MUST use hooks to hang any thing from the pipe & drape. EXHIBITOR IS RESPONSIBLE FOR ANY DAMAGE!
- No live animals, no flames, no candles, no smoking allowed
- May **NOT SELL** any services or goods
- Exhibitors who manufacture, process or distribute food as their normal course of business and would like to distribute food samples are allowed to do so provided that their food samples are no larger than bite-size and the beverages are no larger than three (3) ounces.
- May collect cards for drawing, may not announce winner over mic at event
- Noise level at table must be kept below event background music provided by Qwest Field
